## Section 2. Authority & Declaration

I am aware that the Trustee is required by law to seek my TFN, properly safeguard it, and only use it for legislatively approved superannuation and taxation purposes as specified in the Privacy Act 1988, the Superannuation Industry (Supervision) Act 1993 and the Income Tax Assessment Act 1936. The purposes currently include:

- taxing superannuation payments at concessional rates,
- advising the Tax Office when I receive a benefit or have unclaimed superannuation money,
- allowing the TFN to be forwarded to another fund or Retirement Savings Account if my benefit is rolled-over or transferred unless I advise authorising in writing,
- allowing the fund to locate any other benefits I may have in the fund.

These purposes may be extended by future changes to superannuation legislation.

**If I choose NOT to provide my TFN I am aware that:**

- **Failure to quote is not an offence.**
- **Benefits paid to me may be reduced by income tax deductions made at the highest marginal tax rate, plus Medicare levy (these may be able to be recovered after lodgement of my tax return).**
- **Contributions may attract additional taxation or be rejected by Australian Food Super in certain circumstances (see the reverse side of this form).**

I may also advise the Trustee in writing if I wish to restrict the use of my TFN by not allowing it to be passed to another fund or trustee.

### Section 3. Tax File Number (TFN) notification

The Trustee is permitted by law to use your TFN to identify and amalgamate benefits when making payments, and for other approved purposes.

Your Annual Statement will show if you have supplied your TFN. If you have not supplied your TFN, please contact Australian Food Super.

We are required to tell you the following things before you provide your tax file number to the trustee of your superannuation fund. Your TFN is confidential, and you should know the following things before you decide to provide it:

- We can collect your Tax File Number under the Superannuation (Industry) Supervision Act 1993.
- If you do provide your tax file number to us, we will use it only for legal purposes. This includes finding or identifying your superannuation benefits where other information is insufficient, calculating tax on any superannuation payments you may be entitled to, and providing information to the Commissioner of Taxation. These purposes may change in the future.
- You are not legally obliged to provide your tax file number. If you do not provide your TFN to your superannuation fund, Australian Food Super will be unable to accept any member voluntary contributions from you, any contributions received from your employer will be subject to additional taxation and it may be difficult to identify any lost accounts you hold.
- If you provide your tax file number to us, we may provide it to the trustee of another superannuation fund or to an RSA provider where that RSA provider or trustee is to receive your transferred benefits in the future. We won't pass your tax file number to such trustee or RSA provider if you tell us in writing that you don't want us to do that. We may also give it to the Commissioner of Taxation. Otherwise your tax file number will be treated as confidential.
